TREES IN THE COMMUNITY

Recently we have had several severe storms. Many of us have had tree limbs and or trees fall. The rule of thumb regarding these fallen trees and/or tree limbs is simple. If a tree or tree limb(s) that are in the common area fall in the common area, we leave the downed tree and/or tree limbs where they fall, unless they are creating a hazard. If a tree or tree limbs from the common area fall onto a member's property, the association will remove them. If a tree and /or tree limb do damage to a homeowner's home, they will have to file through their homeowner's insurance for damages, but the association will have the tree and/or tree limbs removed. Also, if the downed tree and/or tree limbs from a tree are from one that stood on the homeowner's property or the township right of way, the homeowner has responsibility for any damage they may cause. This should clarify the association policy for downed trees and/or tree limbs. If a homeowner has a tree on their property and would like to have it removed and are not sure if that tree is on their property for sure, please call the Code Committee and have them come check on it before removing anything. Berkeley Township requires that you have a permit to remove trees.

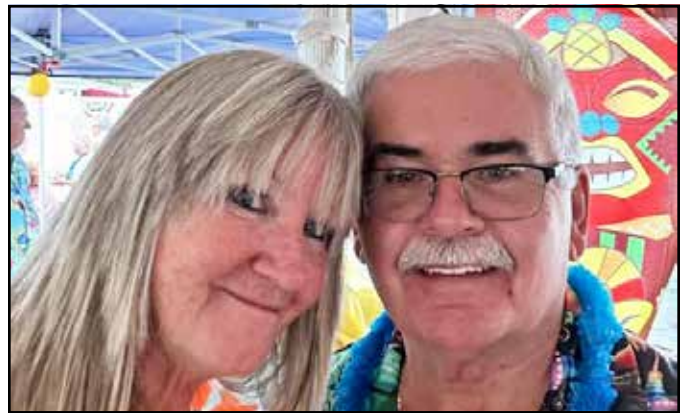

Minutes of the meeting Thursday June 13, 2024

The meeting was opened at 6:11 pm.

It was brought to order with the Pledge of Allegiance and a request for the members to remember those servicemen and servicewomen that are currently serving and those that gave their lives so we can enjoy the freedoms we have today.

Roll call the Board of Trustees: Adrian Corrigan: Yes, Rich Bohan is absent, but sends his best, he's on the mend. Fran Hurley. Is absent and on the mend, she had knee replacement. Linda Hendricks: Here Vince DeChiaro: Here, John Fay: Here and myself, Mike Signorile. We have enough in attendance for quorum.

After the business portion of the meeting, the floor will be turned over to the chairperson of the election committee who's sitting in in the front row. She will conduct the candidate portion of the meeting. Now I'll move on to the monthly business meeting.

I'm going to read the Treasurer's report for Fran since she's not here.

Treasury report: As of today, we have **\$418 543.94** in the operating account. The reserve account has **\$790 889.14** and the deferred account for building C currently has **\$213,022.74** (we have not made the final payment for the rehab of building C, so that money will remain in the account until we get approval for final payment from architect/engineers.) I need a motion to accept the Treasurer's Report as read. Motion Made by Vince DeChiaro, second by Adrian Corrigan. All in favor, non-opposed.

The minutes from the last homeowners meeting of May 9th, 2024. They were printed in the Southwind, it should be noted that the minutes as were transcribed were not verbatim. There were sections where the recording was not clear, and a short description was printed with details as best as it could be heard and understood. Can I have a motion to accept those minutes as printed. Adrian Corrigan - so moved. Can I have a second: Vince DeChiaro - second. All in favor. Non opposed.

Old Business:

The restoration of the auditorium is now truly old business!!

We are finally here! I want to thank everyone for their patience during this process, but here we are, in the auditorium, where we belong.

Legislative matters. The petitions that are being signed for the Social Security bill that was introduced into Congress, HR 7084 are being forwarded to our congressmen and the sponsor of the bill in Minnesota. I had a meeting with Ocean County Senior Services the other day and they are pushing the bill. Even though there's some add-ons, like I mentioned at the last meeting, they still think that the bill might have a shot after the election, so they're going to keep on it and continue to send the petitions to congressional representatives.

There doesn't appear to be any further old business at this time. Does anyone have anything they would like to add.

With no further old business we will move onto new business.

There were some matters that were voted on during the executive session today. They will need to be brought to the floor and read into the minutes.

The first matter pertains to the many emails we received and personal requests from members about extending the hours at the pool. Starting tomorrow, Friday 6/14, through the end of the month the hours will be extended to 9:00 pm and in July, they're going to go to 10 o'clock. In light of the hot weather everyone on the Board voted unanimously to extend the pool hours.

I see Mike (from the Movie Committee) is in the audience. He and his committee are moving forward with the movie night and I'm excited about that as many of us should be. We purchased a new screen that will allow movies to be shown in the tent.

As we know, there's been a lot of back and forth with posts on Nextdoor and Facebook regarding transparency of the board and the fact that there's allegations there's money missing or misappropriated. With that being said the Board took it upon itself to research forensic audit companies to complete a deep dive audit of the association's financials over the last 2 to 5 years. There's an annual audit being conducted right now. In addition to that audit the

Board has decided to move forward with a forensic audit to assure the members that the association's finances are in order. We received three bids that were reviewed by the Board and a unanimous decision was made to accept the bid presented by McKenzie Forensic Auditors. They're well known throughout the industry. This forensic audit is being conducted so everyone can have a clear head and know that there's no funds that have been misappropriated, including the funds that were given to us by the insurance company to rehab the auditorium. It will take between 60 to 90 days to complete the forensic audit.

There's a seminar that's going to be given on Wednesday, July 17th at 10 A.M. It's in Whiting at Village Five, Hilltop Hall. The seminar is about scammers. There's going to be people from Ocean County Consumer Affairs, the State and the Manchester police. It's a free seminar. We're finding more and more people in our age group are getting scammed and the scammers are getting better at it. We have got to be aware of what's going on and they're going to put it all in front of you. I'll get John to see if we can get some of these people here for our neighborhood watch.

Do any of the Trustees have anything else?

Since there the Trustees don't have anything to add I have something I want to read. This is to the members of the election committee. But it's also meant to be heard by everyone.

The Board would like to thank the members of the election committee who have dedicated their time and efforts to ensure that all the proper protocols for our election have and are being followed. These individuals should be commended for their efforts and commitment. The Board would like to add that the election committee members have worked diligently to ensure the upcoming election is run in a fair and unbiased manner and should not be subject to criticism or harassment. They, like all of us, are volunteers. Their efforts should be recognized and appreciated.

Mike Signorile: Now I have something that I would like to cover that involves the Board, but is also personal.

The past several years have been difficult at best. First, we spent two years locked down during COVID and upon our return to normalcy, the trusses in our auditorium failed.

With that being said, The Board would like to address some accusations and statements made by a few homeowners over the past few months and hopefully provide a better understanding for everyone.

It has been said that the current Board is not transparent, that we are spending money without apprising the membership. Then there is the matter of slander and defamation that is constantly being perpetrated on social media with continuous false allegations. All these statements and allegations made with no evidence or facts to back them up.

We would like to set the record straight. Presently, this organization is in the best financial shape it has ever been. There have been no large expenditures other than the remediation of the auditorium and that was covered by an insurance settlement. All other expenditures have been normal maintenance projects listed in the reserve study and were necessary to provide this membership with the best community possible.

*There have been questions as to the publishing of financials in the Southwind. Financials **should not** and **will not** be published until there is a provisional audit completed by the Association's independent auditor. The audit is usually completed by the end of the first quarter. Generally, any time between April or July, depending on the time frame of the annual audit, the financials can be published. This year there has been a delay in publishing the financials. This is due to a restructuring of the office staff which required our CPA to apply for an extension for this year's tax filing. We would like to remind the membership that for the past 8 years we have always had clean audits and our hope is to continue on that path. Once we have preliminary audit findings, the financials will be published.*

With that in mind, every year when the financial and audit findings are published, we invite the members to take some time, make an appointment and sit with members of the Board to review them. In the past, the Board has entertained many members who have had an interest in reviewing the financials and this Board is more than happy to continue taking the time for those reviews. What this Board finds remarkable is the same individuals who continually spew slanderous and defaming remarks, have never reached out or asked to review the available financial documents but instead continue to make statements and remarks without any facts to back them up.

Those few individuals have specifically raised questions of transparency related to the rehabilitation of the auditorium. To those questions of transparency, the Board provided updates every month in the Southwind relaying all information that was available or could be provided without compromising the insurance negotiations.

We would also like to remind everyone that during the negotiations with the insurance company, we received a call from our attorney and the insurance company's attorney, advising us that a member of our community had impropr

erly contacted the insurance company attorney. That individual questioned the process and attempted to determine if we had coverage from the insurance company's attorney. That member is now running for this Board and is the same person **who** called the State and the Township regarding permits for the tent – **who** recently made an OPRA request to the Township in reference to the construction permits for the remediation of building C, and **who** along with another candidate recently contacted the Fire Marshall, filing a complaint regarding the location of the HVAC units, stating their placement violated fire egress codes. These actions have accomplished nothing except cost the association legal and architectural fees to ensure we were compliant and set back the time frame for completion of our auditorium.

This Board is a volunteer board and relies on professional advice when involved in projects. It does not need people second guessing every action taken. There are many more details that we could provide where steps were taken to stall or interfere with Board-related matters, even moving beyond the confines of this association's boundaries.

We can't even begin to address the posts on social media that were completely un-factual and slanderous at best. The point is, this Board has always been transparent and will always continue to be. To ensure those who have questioned the integrity of the current Board, we will be engaging in a forensic audit. This is an additional cost to our annual audit and will squash the accusations and rumors of financial impropriety by members of this Board. This forensic audit will be performed by a firm that specializes in this type of audit to ensure that not only are we financially solvent, but all funds have been accounted for and there have been no unnecessary or inappropriate expenditures. Everyone should be reminded that some of the individuals who are currently running for positions on this Board have made the allegations that initiated and required the need for this expenditure.

Is your Board perfect, absolutely not. Has your Board stepped up to the plate and put its best foot forward when the things went sideways, absolutely!! Integrity and honesty are attributes that are a must for anyone who wishes to serve in a fiduciary position. The decision is yours as to whether unsubstantiated statements and social media post transpose into integrity and honesty. The membership should also be aware that many of the accusations and statements are not directed at the Board as a whole, but single out individuals who in their benevolence have refused to let these inappropriate attacks on their personal character affect their dedication to the Board and this community.

The Board would like to thank you for indulging us for a few minutes so we could provide a brief overview of a few items that at times placed roadblocks or at the very least speed bumps in the way of progress. In most cases, all that needed to be done by certain members was simply "ask" - **realize that they don't know everything - and more importantly "listen"**.

The key to success throughout a community like ours is having individuals who volunteer and become a part of the solution when things get tough, not have their actions create problems. Ask yourself, are these continued allegations and attempts to hinder the ability of this Board to function in the best interest of the membership? Are they part of the solution? Do these actions make any sense?

Take the time to think about the manner in which individuals present themselves and how those same individuals will present themselves when representing this community as a whole. Remember, the reason you elect and place your trust in the members of your Board, then cast your vote.

Mike Signorile: Our legal counsel has just advised me that I have to call for a motion on the forensic audit, which I did not. I apologize for that. I need a motion. Motion made by Vince DeChiaro, second by Adrian Corrigan to approve the proposal submitted McKenzie Forensic Auditors. The initial cost for the audit will be a deposit of \$4,800.00, and the total would be \$12,375.00 dollars. That depends on their findings. If there are additional findings the cost could go as high as \$20,000 to \$25,000. Our hope is there will be no findings and the audit will be clean. I have a motion here on the floor and a second. All in favor. Everyone responded yes. There was no one opposed. Motion passed.

All right, um, I think that's all I have here. Do the trustees have anything. No. Okay, with no other business to discuss. I'm going to call for a motion to close the business portion of the meeting. Adrian Corrigan made the motion, second by Vince DeChiaro. All were in favor with no negative votes or abstentions.

Mike Signorile: I'm going to turn this over to the election committee now. Gail Sanzari, Chairperson.

Peter Ernst: Stood up in the audience and questioned when the members will be able to ask questions of the Board? The Board advised they will be back in July then we are off in August and back in September. The individual insisted on being able to ask questions. He was advised that this was not the forum for questions and that he would be able to address the any questions to the board in July and again in September. He was advised that this time is dedicated to the candidates and if there is time when the election committee has completed their portion of the meeting the

Board will entertain questions.

Mike Signorile: Once again, I'm turning the meeting over to the election committee.

Gail Sanzari – Election Committee Chairperson: Good evening, everyone. So nice to see so many people out here tonight, and I hope I see all of these faces on Election Day. If you attended last month's meeting you got to meet my committee. Unfortunately, my co-chair was not able to be here last month. I'd like to introduce Marianne Petrozzino.

We're going to start tonight with the candidates who wish to give their speeches first, and then follow with questions from the audience. POOL RULES

Rules & Regulations are posted inside & outside the pool area

- ❖ All badge holders must sign in with pool monitor for admittance and show ID badges which must be available for inspection at all times including guests.
- ❖ All persons are asked to shower before entering the water.
- ❖ Any persons showing evidence of (but not limited to) any communicable skin disease, sore, inflamed eyes, cold, nasal or ear discharge or if they are wearing bandages, will be denied admission to the pool area.
- ❖ Do not enter the water if you are experiencing or recovering from diarrhea or have had any symptoms related to a gastrointestinal (stomach) disorder in the past seven (7) days.
- ❖ Children 4 to 18 years of age are permitted into the pool under supervision of an adult between the hours of 9:00 am and 1:00 pm daily. **No child or adult will be permitted in the pool with diapers of any kind.**
- ❖ Residents and Children are encouraged to use the restroom before entering the water. Accompanying adult should immediately report any accidents observed in the bathing waters to a pool monitor.
- ❖ No animals, with the exception of service/emotional support dogs with proper identification, will be permitted in the pool area.
- ❖ Long hair and beards need to be tied up while using the pool. Hair bands are available at the pool monitor station.
- ❖ **No alcohol** of any kind will be permitted in the pool enclosure. Glass containers are **prohibited** in or around the pool enclosure.
- ❖ Persons suspected of being under the influence of drugs or alcohol will be prohibited from entering the pool. Any person found to be drinking alcohol or under the influence of drugs while in the pool area will be escorted from the pool area and may be denied admittance for the remainder of the pool season.
- ❖ Food or snacks are permitted in and around the pool area. Pool area must remain clean at all times and cleaned before departing. All violations will be addressed.
- ❖ Conduct that endangers the safety and comfort of others is prohibited and could be cause for violators to be escorted from the pool area and may be denied admittance for the remainder of the pool season.
- ❖ Flotation devices, such as standard size noodles and children's water wings/swimmies are permitted in the pool. Any type of inflatable/blow-up tubes, rafts, flippers or swimming devices are not permitted in the pool.
- ❖ Only bathing suits are permitted in the pool. Cut-offs, street clothes or substitute swimwear are not allowed to be worn in the pool. This will be enforced by the pool monitor.
- ❖ For safety, and as a courtesy to others, please place footwear along the edge of the pool, but not near or around the handrails/steps used to entering or exiting the pool.
For safety, and as a courtesy to others, please do not sit on the pool steps or near the step pool rails.
- ❖ No smoking or vaping will be allowed by the picnic tables or in the pool area. Designated smoking areas are posted.
- ❖ The pool will be closed, during inclement weather or emergencies.
The only areas of the Clubhouse accessible to pool users are the Men's and Women's bathroom in Building C.

RECYCLING PICKUP

There have been many phone calls and emails regarding the pickup of recycling when the date for pickup falls on a holiday. The schedule that is provided by the Township states that recycling should be put out the Saturday before a Monday holiday. Discussion with the Township DPW supervisor provided us with information that should help with planning for the pickup of recycling when the schedule for pickup falls on a Monday holiday.

We were advised that when our recycling day is moved to another day due to a holiday, we are now on a pickup schedule with another section of the township which more than doubles the amount of recycling that will be picked up on that day.

With that thought in mind we need to understand the Township DPW will make every effort to pick up the recycling on the day denoted on the schedule. ***If they do not pick up your recycling by the end of the day on the scheduled day, please take your recycling in.*** This is an important step in the process. This will prevent recycling that is left out from getting blown around the neighborhood or ending up tangled in the swales and culverts on our common grounds. ***The DPW suggests that if your recycling does not get picked up on the scheduled day, we should put it out on the next regularly scheduled workday.*** In most cases that would be Tuesday, or Garbage pickup day. The DPW will continue to have recycling trucks making rounds until they are completely caught up and all the recycling is picked up.

Foreground Objects

This month we'll discuss a compositional topic – including a foreground object. When shooting landscape images, most people position themselves so there is nothing close in the picture, only the landscape in the background. Without a foreground item to anchor the image, your viewer has no sense of distance. Sure that's a pretty mountain, but how far away was it?

By including a foreground object you give a sense of depth to the image and the viewers can better immerse themselves into the scene. Never center the foreground anchor (remember your rule of thirds) – it should be off to the side, which will help lead the viewer into the scene.

This technique is not just for landscapes, but works with indoor images of large rooms, shots in your yard, and any situation where you're trying to portray depth in your image. This foreground object can be used to frame your subject.

Combining foreground objects with good exposure and utilizing the other tips we've previously discussed will yield you some great images.
